- 1- My age is not under 21 years, and I have full legal capacity.
- 2- I have not been convicted of a felony, offense against honor or loyalty, or any of offences set forth in article no.40 of the law no.8 for the year 2012 concerning Qatar Financial Markets Authority, and the two articles 334 and 335 of the law of commercial companies promulgated in virtue of the law no.11 for the year 2015 along with its amendments.
- 3- I do not break the provisions of the law in this regard, and in accordance with article no.7 of the Code of the governance of companies and legal entities on the main market issued by the Board of Directors of Qatar Financial Markets Authority. - 7- I have never been adjudicated bankrupt/ I have previously been adjudicated bankrupt, but I was rehabilitated.
- 8- I do not have interests which are in contravention with the interests of Gulf International Services Company group.
- 9- I do not have other personal or professional obligations which may limit or obstruct my ability to meet my obligations properly as a member to the board of directors of Gulf International Services company along with its shareholders.
- I do hereby affirm that the foregoing is correct, and I will be held responsible if the contrary is proved or in case of contravention with the provisions of the law, or the system of governance of companies or legal entities included in the main market, issued by the Board of Directors of Qatar Financial Markets Authority.
